WHISTLEBLOWER POLICY. UBF FACULTY-STUDENT HOUSING CORP. MUST HAVE ITS OWN  
BOARD OR BOARD COMMITTEE HANDLE ITS CONFLICT OF INTEREST AND  
WHISTLEBLOWER POLICY MATTERS, ALTHOUGH INPUT FROM THE UB FOUNDATION AUDIT  
COMMITTEE MAY BE REQUESTED.

ARTICLE II, SECTION 14 WAS ADDED TO DEFINE THE CORPORATION'S POLICY ON  
CONFIDENTIALITY.

ARTICLE II, SECTION 2, COMMITTEES OF THE BOARD, NOW INCLUDES THAT MEMBERS  
OF EACH COMMITTEE OF THE BOARD, EXCEPT FOR THE EXECUTIVE COMMITTEE, SHALL  
BE APPOINTED BY A MAJORITY VOTE OF THE BOARD, A QUORUM BEING PRESENT AND  
THAT MEMBERS OF THE EXECUTIVE COMMITTEE SHALL BE APPOINTED BY MAJORITY  
VOTE OF THE ENTIRE BOARD. ARTICLE II, SECTION 2, COMMITTEES OF THE  
CORPORATION ALSO ADDED THAT MEMBERS OF EACH COMMITTEE SHALL BE APPOINTED
